Thank you for helping your fellow darters by agreeing to Captain the team.

Rules of Play

Read and become familiar with the Rules of Play which are provided in your Captain's packet (and on the website). If you have questions or problems, contact the Executive Director or your Regional Director.

League Nights

The Team.

Ensure your team members know where each match is to be played. Captains fill in the lineups for the first section of play which must be exchanged by 8 pm, and the first game must be started by 8:10 pm.

Score Sheets.

Captains are responsible for the completion, accuracy, and neatness of their score sheets, and must sign them both at the end of a match. Both team captains are responsible for mailing or faxing (888 476-0663) their respective score sheets to WADA. Score sheets must be faxed/postmarked within 48 hours of the match. Three (3) penalty points will be assessed for failure to submit score sheets by the deadline. Each player's full name and WADA number must be entered once on each score sheet.

A blank copy of the scoresheet is in your captain's packet. An executable file is available on the website along with a sample scoresheet with instructions for how to fill it out properly.

Reporting Results.

Immediately following the match, both team captains must report the match results to WADA. Failure to report scores by noon the following day will result in the assessment of three (3) penalty points. Scores may be reported by phone (888 476-0663) or email (scores@wadadarts.org) by the deadline.

Roster & Shooters Fees

The team roster, membership fees and shooters fees are by the end of the 3rd week. Three (3) penalty points will be assessed (each week) for failure to submit roster/fees by the deadline.

Begin collecting money and roster information from your players the first week of play. No refunds/credits will be issued. If you've not collected from all team members, mail what you have (in order to meet the deadline). Players may be added through the end of Week 9.

Complete ALL information on the team roster. WADA does NOT sell nor share it's members' information – it is only for internal WADA use.

Web Site

Visit the website regularly for information and updates. It is your responsibility to check your team's information on the website to be sure the Roster is correct and shooters and sponsors fees payments show paid on the website.

Newsletter

The **WADA Weekly** newsletter is posted on the website and emailed to all current season shooters (for whom we have email addresses in our membership database) each week.

Season Checklist

Week 1

___ Begin filling out the Roster & collecting fees.

Week 2

___ Mail Roster & shooters/membership fees or pay online and email or FAX roster

Week 3

___ Roster & fees must be received this Saturday.
___ Sponsor invoices are mailed this week.

Week 4

___ Penalty points (3 points per week) assessed for teams with rosters & fees not received.

Week 5

___ Check the website to be sure your Sponsor fees are paid. Contact Sponsor if necessary.

Week 6

___ Roster & fees must be received this Saturday
Or team will be dropped for rest of the season
___ Sponsor fees must be received this Saturday
Or team will be dropped for rest of the season

Week 7

___ Check Weekly/website for dropped team(s).

Week 8

___ Check roster on website – Is it complete? Are names spelled correctly?

Week 9

___ Last week for subs or to add new players.

Week 10

___ No more subs or new players.
___ No postponements without prior approval of Executive Director for balance of season.
