Co-Executive Director – Ronda Daly (Tim is playing a playoff match)

- NEW TROPHIES PROVIDER - a darter who is providing for other leagues. Trophies will be less expensive (around \$800 cheaper) and look better. We will get charged for supplies and some markup for time. TriCoda's trophies look amazing.
- PINS - New trophy provider can do label pins for \$1 each. Players care more for 1st pin. We still have 5th and 10th pins. Will add Div Champ pins. Plan to do 1 order, see if we like, then add more..
- RULES - Ronda went thru all the Rules, entire doc, top to bottom and reviewed with Tim. Will send to board members tonight for thorough review and comments.
 - Set limits on A/B/C levels, proposing balance/team averages. Looked at prior seasons. NEED INPUT from board members.
 - Will document prizes for singles based on # of shooters.
 - Will post in Teams for doc sharing - for board comments.
 - Will send for final review by Jun 15th. OK to discuss with board members.
- END OF SEASON LOD - Tentative 7/11 date to allow forming teams for next season. Give out trophies for this season. Give out pins.
